Due to the restrictions of class size, <u>application to the program does not guarantee acceptance</u>. Acceptance is a very competitive process. Just because you meet the minimum standards does not guarantee acceptance. We are currently accepting up to 20 students. Falsification of any information on the application will result in dismissal of your application.

Deadline for application is July 18, 2025 for the 2025 school year. Deadline for turning in required documentation is July 31, 2025.

| V | Must be 18 years of age prior to the program's start date in September. |

| V | High school transcripts with GPA and ACT scores noted on transcript are required unless you have a BS degree. |
| | An applicant with a GED certificate must have a 50 overall score with a score of 50 on all sections. If the GED scores do not |
| | meet these requirements, then the applicant must have a college cumulative GPA of 3.0. |
| | College transcripts are required from all locations attended. |
| √ | MANDATORY required college courses that must be taken and completed with a minimum grade of a C. |
| | Intermediate College Algebra or College Algebra |
| | Fundamentals of Public Speaking or Oral Communication (Must be a 3 hour class) |
| | English Composition I |
| | Anatomy & Physiology I If A & P courses are successfully passed on 1st attempt, an additional point will be |
| | Anatomy & Physiology II awarded on the applicant's interview grade point sheet. |
| | Grade points : A = 4 points, B = 3 points and C = 1 point |
| V | Additional Courses - these are not required but will give additional points and will help you tremendously. |
| | Medical Terminology |
| | Intro to Physics at Bevill State |
| V | College GPA |
| | The applicant must have a minimum cumulative college GPA of a 2.5. |
| | GPA must be noted on all transcripts. |
| √ | ACT score – must be noted on transcript or have a copy from the ACT. |
| | Composite score of 18 is required. We do not require the writing portion of the ACT. |
| | If an applicant has a score of less than 18; then they must have a cumulative college GPA of 3.0 or higher. |
| | The ACT is not required if the applicant has a BS degree in any subject with a minimum final cumulative GPA of 2.5. |
| | ACT cannot be older than 10 years. |
| | We only accept the National ACT. In accordance with ACT, the residual ACT is only for the school it was taken for. |
| V | Reference letters |
| _ | Three reference letters from individuals other than family are required. The letters can be mailed, faxed or emailed. |
| | These letters are to be postmarked or received no later than July 31. |
| √ | Observation visit – subject to change |
| | An observation visit is where the applicant will be toured to some of the clinical educational sites where training will occur. Th |
| | is your chance to see what a day is like for a Radiologic Technologist. You will be notified by the School Agent when it is time to |
| | schedule. These visits can be scheduled AFTER your transcripts have been received. |
| | Observation visits are only held Mon – Fri at Regional Medical Center from 7 a.m. – 2:30 p.m. and are in-person. |
| V | Interview |
| | An interview will be scheduled for all applicants who have completed requirements by the deadline. This is scheduled by the |
| | School Agent and you will be notified by email after the July deadline. Interviews are only held once and will be held in August |
| V | Acceptance notification, background check and pre-employment physical |
| | If accepted, applicant must pass a background check. Due to this, we reserve the right of up to 3-weeks delay from interview t |
| | notification. Applicant must also complete the DCH pre-employment physical prior to school start date in September. |
